

BALLSTON SPA HIGH SCHOOL STUDENT PARKING GUIDELINES

Driving to school is a privilege available to Juniors and Seniors only.

School Administration has the right to revoke a student's parking permit at any time.

The student assumes all responsibility for loss or damage to his/her car, its equipment and contents.

In the event of an accident on school property, students should call local law enforcement.

SENIORS:	May only park in your assigned numbered spot in either the Senior Lot or Junior Lot. <i>*Note: Spots will be assigned in the Junior lot once the Senior Lot is full.*</i>
JUNIORS:	May only park in your assigned numbered spot in the Junior Parking Lot.

- ✓ **Students should only park in their assigned numbered parking spot** and **MAY NOT** parking in any visitor or drop-off/pick-up loop parking areas (to include the softball field side), any non-marked spots in any lot on school grounds or in any faculty lot. *Cars without permits or cars with student permits parked illegally will be towed at the owner's expense.*
- ✓ All student drivers must have a valid NYS Driver's License to receive a parking permit.
- ✓ A \$15.00 non-refundable parking permit fee will be collected at the time the parking permit is issued.
- ✓ Parking permits must be **permanently affixed** inside on the **passenger side, rear window.**
- ✓ **Students who possess a parking permit are expected to be on time to school and be in good academic and behavioral standing.** Failure to do so will result in loss of parking privileges.
- ✓ Student vehicles parked on school grounds may be subject to search by administration if there are reasonable grounds to suspect they contain items in violation of laws or the school code of conduct. If necessary, the police will be notified of contents within the vehicle.

Leaving the building to go to your car during school hours without permission.	Warning	Loss of parking permit for 5 school days.	Loss of parking permit for 10 school days.*
Driving in a manner that endangers the safety or property of others.	Loss of parking permit for 10 school days.	Loss of parking permit for the remainder of the school year.	
Cars will be towed at STUDENT EXPENSE if:	<ul style="list-style-type: none"> - The student drives to school but does not have a parking permit. - Parking privileges have been suspended or revoked. 		

*Additional infractions may result in the loss of parking privileges for the remainder of the school year.

**Students may also receive additional consequences based on the infraction/violation.

***Students **SHOULD NOT** be transporting other students to/from Tec-Smart or BOCES. All parking guidelines required by these facilities must also be followed in conjunction with Ballston Spa High School guidelines.
