SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. The district will provide:

1. Additional cleaning staff in each of our six buildings to maintain daily cleaning and deep cleaning standards established during the 2020-2021 school year.
2. A COVID-response coordinator to work directly with the nursing staff, county health, parents, and staff to manage efficient contact tracing and communications.

4. **In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.**

The District will utilize data from:

1. Our current counseling, McKinney Vento, mental health, and summer program staff.
2. The readiness survey that is a required component of the *Primacy Project* program which is currently in place in one elementary school and is being implemented in a second school this fall.
3. Our contracted student and family services provider (Parsons) which will be expanded utilizing funding from this grant.
4. Special education staff from our ESY program as well as our school psychologists who are evaluating and reevaluating our students. An additional psychologist will be added through this grant to enhance these processes.
5. Related services staff particularly in speech which has a high identification rate in our district. A speech improvement teacher will be added with funds from this grant to ensure that students in grades K-1 are proactively provided services and instruction that will more consistently keep them in the classroom and assist with their development of skilled reading.
6. Reading and mathematics intervention teachers who service students during the summer and at the outset of the school year. Funding from this grant will allow us to provide additional training on effective reading instruction practices to teachers to ensure that students who have lost instructional time are receiving effective instruction in reading.

The district utilized general fund monies for our summer enrichment programs and will utilize the ARP-ESSER funds in part to provide:

1. Additional coaching and curriculum and instructional support teams to train on and implement the Multi-Tiered System of Supports for all students.
2. Additional technology coaching for the efficient and effective use of technology in providing instruction to in-person and remote learners as well as to support parents who are utilizing remote instruction at home.
3. Additional classroom staff to allow for access to courses and opportunities that were reduced or eliminated during the pandemic restrictions/closures that would otherwise impact students' abilities to complete their requirements.

The district will invest in updated technology that will allow for greater consistency in the delivery of instruction and services to student and families.

Utilizing a combination of general fund, Title, ARP, CRRSA funds, the District has created a comprehensive, braided approach to providing for and monitoring the success of our students in the coming year where we are investing in additional classroom staff, a school-family liaison for McKinney-Vento students and families, related services and counseling staff, behavioral and teacher coaches, instructional teacher leaders, trainings, services, and programs. Our curriculum and tiered intervention data collection will allow us to see the impact of these investments and readily make adjustments where needed. Mid-year assessments and parent surveys will determine whether we have had the expected impact on those students for whom the additional services and support are designed.
